Workshops round 1 - September 28, 14:00-15:00 CEST

WS 01 The conference on the future of Europe's Plenary: desirable innovation or smokescreen?

Stream: Political buy-in

In most deliberative processes, citizens formulate recommendations before handing them over to decision-makers. The CoFoE's Plenary was designed as an intermediary step between these two stages. During the Plenary sessions, citizen Ambassadors from the panels worked alongside representatives of civil society, members of the European institutions, and national Parliaments. The purpose of these sessions was to debate, enrich, and confront the recommendations with the reality and the functioning of the institutions, in a mixed audience setting. In this workshop we propose to explore whether or not the Plenary had an added value.

WS 02 Enclave deliberation

Stream: Inclusive participation

In this workshop we will explore our collective experience of enclave deliberation, where like-minded people deliberate, whether minority or specialist groups. This will be an interactive collaborative workshop covering both the research and practical experience of Democracy R&D members. We will explore questions of whether this is a solution for involving minority groups more substantially in deliberation and/or whether it leads to less compromise and greater polarisation.

WS 03 Wartime democracy: what's going on w/ democracy & how to cope w/ war? Experience of Ukraine

Stream: Democracy in (times of) crisis

We invite everyone to think about the following questions together with the workshop's key speakers: How is democracy possible in times of war and post-war national recovery? What is the strength of democracy in the fight against military aggression? What are the fundamental challenges to democracy under the neo-imperial military aggression of Russia against Ukraine as well as under the further post-war national recovery? How to keep democracy on a 'razor's edge' between risks of failure in authoritarianism vs. chaotic populism under the (post-)war, between a rigid and ruthless public policy produced by the elites, and a soft agentic democracy produced by the civil publics? What lessons can we learn for further development of deliberative democracy?

WS 05 Gardener, sailor, firefighter - a collaborative response in times of crisis Stream: Democracy in (times of) crisis

In the UK, we are seeing a rolling back of democratic norms and freedoms, with new laws being put through parliament restricting the ability to protest, removing the independence of the electoral commission and disenfranchising millions of voters through the introduction of voter ID. This

workshop will host a panel discussion hearing from three different initiatives and projects that are responding to the threats to democracy whilst also seeking to renew UK democracy through building a movement for change.

Our current democratic institutions fail to reflect society's diversity, they tear us apart, they concentrate power in the hands of the few. We need new democratic institutions - permanent deliberative institutions with rotating citizen representatives at the heart of the democratic system. In this workshop we will take a step to the future and, inspired by existing examples and principles of representation, rotation, and deliberation, we will open up the space to imagine new citizen deliberation based democratic institutions for different parts of the democratic system.

WS 07 Beyond crisis: reimagining democracy urgently for a shared future Stream: Political buy-in

This workshop will build on Involve's blog series on visions for the future of democracy in which various contributors imagined what the landscape of deliberative democracy in the UK would look like in 2035. Using and demonstrating futures techniques, participants will have the opportunity to creatively share experiences, knowledge and ideas on their visions for democracy, to move us beyond today's constraints into a more hopeful shared future. While this uses a longer term time horizon than today's crises, it's prompted by the urgency we feel today - to get going now, with the radical solutions which will improve the future.

Often citizen deliberations are seen as 'filling empty buckets' with the expertise of commentators or witnesses to enable an informed deliberation. Our concern is that this can diminish the validity of lived experiences, reduce the communicative impact with the wider public, be a bar to marginalised community members

feeling confident to voice divergent opinions and reproduce structural inequalities. We want this workshop to explore 'what is valid knowledge', and 'how to release lived experiences'.

Scholars and activists who undertake such inquiries are invited to jointly develop reflections, arguments and/or proposals for the conversation at stake.

WS 13 Let a thousand flowers bloom: scaling out and replicating citizen deliberation

Stream: Political buy-in

Shared Future CIC and Delibera Brasil are both involved in programs to encourage more local municipalities to develop more deliberative processes. We want to share with and learn from DRD colleagues how to approach scaling out (spreading the practice) to local administrations of different sizes, when it may not be possible to accompany all those processes, and the cost of a fully facilitated process are beyond the reach of smaller municipalities. It's important each deliberation is context specific, and responds to local circumstances, and also that good design choices are made, and local

capacity built. Challenges exist around maintaining quality, ensuring best practices are followed and coping with the inevitable limitations on resources, capacity, timing as well as political instability. What does it require to let go of direct control, replicate what works, whilst maintaining consistency and quality?

WS 14 Next level citizen participation in the EU - institutionalising European citizens' assemblies

Stream: Political buy-in

The starting point for discussion will be the model of European Citizens' Assemblies proposed by the Bertelsmann Stiftung together with Gabriele Abels, Alberto Alemanno, Ben Crum, and Alexander Trechsel.

WS 15 Including the ignored

Stream: Inclusive participation

Hard to reach is the phrase that has been popularised to define those communities disengaged. However, those communities are rather ignored than disengaged. They are usually represented by saviour organisations that 'provide them with a voice', while they are not voiceless, they simply do not have the means to be heard. In this workshop, FIDE will look at the narrative of inclusion with critical eyes and will facilitate a space to improve deliberative democracy by including the ignored.

WS 17 Bursting our bubble: using deliberative practices for constitutional reform & political result

Stream: Democracy in (times of) crisis

Deliberative democrats around the world are bumping up against cramped and outdated laws and practices--both formal and informal--as we strive to address pressing problems. Often, we think "there is nothing we can do about it" and are content to create reports in our own cosy bubbles, without directly taking on those outdated systems or engaging with duly elected representatives. We feign surprise or even talk of "betrayal" when no political change follows. Can we use the tools of

deliberative democracy to bring change to those systems and forge relationships with elected representatives? During this workshop, we will revisit foundational but often outdated democratic structures and norms and suggest how we can evolve the local, national and global democratic space and recreate our democratic culture to be fit to solve seemingly intractable problems.

TS 01 Decision-makers as movers and shakers, communities as moonrakers: comparing two models

Our two case studies are Newham Councils' Democracy Commission and its recommendation for a Standing Citizens' Assembly and the surprising innovation resulting from London School of Economics Students' Union Democracy Review. We invite people to explore multi-directional layers of political buy-in for ongoing, regular institutionalised deliberative democracy processes. By sharing our experience and emerging impact from two case studies, we encourage participants to roll up their sleeves, delve in and explore both top-down and bottom-up approaches. Our workshop will discuss the merits and risks of both, with an aim to unlock thinking, ideas and better planning for ongoing processes based on both top down and bottom up political buy-in.

This resulting method builds on the Open Space principle of 'the whole system in the room' and sees, among other aspects, political buy-in secured through partnerships, mechanisms for wider stakeholder buy-in and participation, and special attention to the language of the citizens' proposals. The G1000.nu team will share the lessons they learned over the years and together we'll explore how the resulting approach allows for impactful deliberative processes.

TS 10 Democratic infrastructures: turning one-off deliberations into resilient democracies

Today, democracy faces fundamental challenges—polarisation, democracy 'washing', power unbalance, digitalisation and climate change, and democracy 'myopia' amongst others. As a response, we propose designing and building 'Democratic Infrastructure', which strategically connects moments of deliberative democracy with other instruments of democracy—including other processes, networks, and capabilities—which are fit for purpose to engage our current and future crises. This session will introduce some of our thinking while primarily focusing on working with other practitioners to explore how we might enable our limited-duration deliberative events to become long-term democratic infrastructure.

TS 11 How to train politicians and senior leaders on climate engagement

This "train the trainer" session will share learning on how best to train politicians and senior leaders in local government to make the most of public participation to help them tackle major challenges; using the example of the climate emergency. It will draw on learning from our work training politicians and senior leaders from over 20 Local Authorities across England in 2022 to share best practice and what we have learned about helping them understand the value of public participation, how it relates to their roles, what good looks like and addressing common challenges they face. After this session you will be able to design training which helps leaders initiate and communicate public engagement; and also helps them set individual projects in a context of building the infrastructure they need for continued public engagement.
